### **The Business Valuator**

*The Business Valuator* is an informational newsletter on the Institute, the activities of its Members, and the Valuation Profession. It is usually published four times a year.

The Editor (Chair of Communications Committee) and the Communications Manager are responsible for planning, soliciting articles and editing. The President & CEO is responsible for final editing and assembly. This is an online publication.

No subscriptions are offered for *The Business Valuator*, but “Employment Opportunities” advertisements are solicited. Charges for advertising are to be determined by the President & CEO.

Students and Members who wish to place an ad in this publication, seeking employment, may do so at no charge.

*The Business Valuator* is sent electronically to all Members, subscribers and Registered Students free of charge. It is also posted on the website (public access).

### **The Journal of Business Valuation**

*The Journal of Business Valuation* is published annually and consists of papers presented at national and regional conferences, research papers, papers authored by CBVs, and articles reprinted from leading valuation journals and magazines that are of interest to CBVs. The Editorial Board is responsible for selecting topics to be included in the Journal. The Communications Manager is responsible for assembling all the materials included in this publication, obtaining pertinent copyright permissions, and working with the editor and publisher (Carswell, a Thomson Reuters Company).

*The Journal of Business Valuation* is used as a text for some of the Institute courses, and the relevant back editions are sold to Registered Students requiring them for these courses.

Members and Registered Students receive a complimentary copy of current issues.

1. *Corporate/Securities Decision and Regulatory Developments* is a joint publication of the Institute and Miller Thomson LLP.
2. *Taxation Decisions and Legislative and Administrative Developments* is a joint publication of the Institute, Ed Kroft of McCarthy Tetrault LLP and Dennis Turnbull formerly of the CRA.
3. *Family Law Decisions* is a joint publication of the Institute and Terry Hainsworth of Harrison Pensa LLP.

These publications are published approximately once a year and distributed free of charge to Members, subscribers and Registered Students.
