



# TOP CBV UNDER 40 IN MEMORY OF DAVID CORNFIELD, CA, CBV

## POLICY

---

THAT the CICBV Top CBV Under 40 Award is intended to recognize younger CBVs who have demonstrated success in a broad diversity of interests. Those successes will likely be in a combination of professional and personal life endeavours.

The Top CBV under 40 Award will be granted each year to a deserving CBV. This Award will consist of a recognition plaque and \$750. The Top CBV Under 40 Award will be presented at the Awards Ceremony which will be held in conjunction with the CICBV conference. News of the award will be shared via Member communications, i.e. — CICBV website, Newsletter, and possibly the National Post/Globe and Mail.

### Award Criteria

The award is open to all CICBV Members in good standing who are under the age of 40 by the application deadline of January 31st and who have not previously been recipients of the award.

Nominators must demonstrate that the nominee has brought distinction to the Profession and/or given outstanding service in one or more of the following areas:

1. **Career Accomplishments**
  - Excellence in Business Valuations, career position, other professional/ academic achievements, etc.
2. **CBV Profession — Service and Contributions**
  - Involvement with the CICBV and regional/national CICBV events/workshops.
  - Involvement with other professional bodies or business-related organization.
  - Promotion of the Profession: communications (speaking, writing, media), recruitment of students, etc.
3. **Education**
  - Contribution to CBV education, teaching, mentoring, coaching, etc.
4. **Community / Charity Service**
  - Charitable community work, service to the profession and other business groups.
5. **Other**
  - An open category to include personal interest activities such as sports and arts, etc.

Successful nominees will likely display the highest level of leadership/achievement in more than one category while demonstrating a notable level of success in several others. Importantly, candidates should clearly be known as Chartered Business Valuators in making the achievements cited in their nomination. Nominees will exhibit characteristics of innovation, creativity, leadership, impact, and positive attitude.

### Judging Criteria

Nominees will be judged on the following criteria:

- Impact of the accomplishment on his or her career.
- Impact of volunteerism on his or her community.

### Judging Committee

The Awards Committee will judge nominations for the CICBV Top CBV Under 40 Award, and make a recommendation for approval by the Board of Directors. Members of the CICBV Awards Committee are not eligible to be nominated.

### Nominating Procedure

Any CBV may nominate another CBV by providing an information packet containing:

- Completed nomination form.
- A signed letter containing supporting reasons why the nominee satisfies the award criteria.

All nominations must be sent to the attention of: "CICBV Top CBV Under 40 Award," c/o President & CEO, The Canadian Institute of Chartered Business Valuators by **January 31st of each year**.
