ASSISTANCE REQUIRED – CBVS PRACTICING IN FAMILY LAW

A research proposal submitted by Mr. Jean-Claude Desnoyers (FCPA, FCA, CBV) and Ms. Alexandra Danis, LL.L, CHRP, “Best practices for CBVs in determining the available income of the owner of a company under the Federal child support guidelines” was a recipient of the 2019 Ian R. Campbell Research Award.

Mr. Desnoyers and Ms. Danis’ research is timely and will be extremely informative to valuers and the legal community. The first stage of research involves conducting (with the support of CBV Institute) roundtable sessions with CBV Members on **February 24th, 25th, 26, and 28th**. Each session will address one area of their research. Further stages of Mr. Desnoyers and Ms. Danis’ research will involve case law review and obtaining input from the Canadian legal community.

A BRIDGE FROM CBV INSTITUTE PRACTICE STANDARDS TO IVS NOW AVAILABLE

CBV Institute is at the forefront of the global valuation community and has determined to continue to advance changes to CBV Institute Practice Standards and pursue adoption of International Valuation Standards (IVS)

through further due diligence and consultation. CBV Institute Practice Standards and IVS are largely consistent, however differences do exist, which have practical implications to practitioners.

As part of this consultation process and to assist members’ in applying IVS, CBV Institute has published A Bridge from CBV Institute Practice Standards to IVS to highlight areas of differences between CBV Institute Standards and IVS.

As IVS continues to gain recognition and use internationally, there will be an increased need for CBVs to meet the requirements of IVS.

GLOBAL DATABASE OF VALUERS TRAINED IN IVS DO YOU QUALIFY?

The IVSC will soon be launching a global database of valuers, searchable country-by-country, enabling members of the public to make informed decisions when selecting a valuation professional. By taking IVS training, CBVs can be included in this database, providing individual members an opportunity for global recognition and identification.

Winter Course Exams and Practice Quiz – Examity Scheduling Deadline (Wednesday March 4th 2020)

Students must create a profile and schedule their course exams with Examity by Wednesday March 4th. Students must write their exams using Examity (no exceptions).

Further, Students are encouraged to register for and write a Practice Quiz in Examity. The purpose of the Practice Quiz is to give Students the opportunity to experience the Examity environment, including connecting to an online proctor and uploading a response file; and to familiarize Students with the Institute’s Examination Rules.

The last day that Students can write the Practice Quiz is Friday March 6th, and the last day that Students may sign up to take a Practice Quiz is Thursday March 5th (i.e., 24 hours prior to when the Student wishes to write the Practice Quiz). The answers to the Practice Quiz will be available in Moodle on Monday March 9th.
