PROFESSIONAL PRACTICE MATTERS – GOODWILL IMPAIRMENT VS

AMORTIZATION

After receiving 100 comment letters and holding a roundtable meeting in November 2019, FASB is continuing to seek feedback on its project titled "Identifiable Intangible Assets and Subsequent Accounting for Goodwill", and is conducting a thorough, multi-year, outreach process on this difficult issue. Strong views have already been expressed by market participants on both sides, with members of the valuation community, including CFAs, expressing concern over a move "backwards" to goodwill amortization.

The IASB is also investigating possible improvements to IFRS 3 Business Combinations and IAS 36 Impairment of Assets, and is in the process of drafting a discussion paper, expected March 2020. The FASB and IASB are jointly discussing the goodwill topic and are mindful of the international impact, which could be disruptive if the US takes one approach on goodwill and the IASB another.

We will continue to monitor these developments.

EXAM OPT OUT DEADLINE - WEDNESDAY FEBRUARY 26, 2020

York University has sent all students a link to opt-out of their course exam if they so wish. After opting-out of an exam, a reduced re-enrolment price will automatically apply when you register for that course in the next semester. Students will not be permitted to opt-out of their exam after this deadline.

CPA CANADA CALL FOR CONSULTANTS

A BRIDGE FROM CBV INSTITUTE PRACTICE STANDARDS TO IVS

NOW AVAILABLE

CBV Institute is at the forefront of the global valuation community and has determined to continue to advance changes to CBV Institute Practice Standards and pursue adoption of International Valuation Standards (IVS) through further due diligence and consultation. CBV Institute Practice Standards and IVS are largely consistent, however differences do exist, which have practical implications to practitioners.

As part of this consultation process and to assist members' in applying IVS, CBV Institute has published A Bridge from CBV Institute Practice Standards to IVS to highlight areas of differences between CBV Institute Standards and IVS.

As IVS continues to gain recognition and use internationally, there will be an increased need for CBVs to meet the requirements of IVS.

Winter Course Exams and Practice Quiz – Examity Scheduling Deadline (Wednesday March 4th 2020)

Students must create a profile and schedule their course exams with Examity by Wednesday March 4th. Students must write their exams using Examity (no exceptions).

Further, Students are encouraged to register for and write a Practice Quiz in Examity. The purpose of the Practice Quiz is to give Students the opportunity to experience the Examity environment, including connecting to an online proctor and uploading a response file; and to familiarize Students with the Institute's Examination Rules.

The last day that Students can write the Practice Quiz is Friday March 6th, and the last day that Students may sign up to take a Practice Quiz is Thursday March 5th (i.e., 24 hours prior to when the Student wishes to write the Practice Quiz). The answers to the Practice Quiz will be available in Moodle on Monday March 9th.
