DID YOU KNOW...

IVS 2017 HAS BEEN UPDATED AND RE-ISSUED AS "IVS"

The latest edition of the International Valuation Standards (IVS) has now been published. Going forward, the year of publication is no longer included in the title of the standards, such that the standards are now simply called IVS (rather than IVS 2019). This latest edition of IVS includes several changes:

- a new chapter, 'IVS 220 Non-Financial Liabilities' as part of the intangible asset standards
- technical revisions consulted on throughout 2018 and 2019

- an updated IVS Glossary
- updated standards on 'limitations' (IVS 102), and 'valuation models' (IVS 105).
