DID YOU KNOW ... PRACTICE INSPECTIONS REQUIRE YOUR CLIENTS TO PROVIDE CONSENT

Having your clients provide you written informed consent for disclosure for purposes of a CBV Institute practice inspection is an important part of the Practice Inspection Program. Without informed client consent, Members and Registered Students may have a hard time meeting their professional obligations as part of our Practice Inspection Program. As outlined in the Mandatory Practice Inspection Policy, it is strongly recommended that the ability to disclose be a precondition of accepting an engagement.

While Client consent for disclosure may be obtained at a later date, written consent should be obtained at the start of the engagement. As a best practice, consent should be sought as part of your engagement letter. **Sample consent wording is now available.**
