CBV INSTITUTE STUDENTS - EXAMITY EXAM SCHEDULING AND EXAM PRACTICE QUIZ

Fall Course Exams and Practice Quiz – Examity Scheduling Deadline (Monday October 28th, 2019)

Students must create a profile and schedule their course exams with Examity by October 28th. Students must write their exams using Examity (no exceptions).

Further, Students are encouraged to register for and write a Practice Quiz in Examity. The purpose of the Practice Quiz is to give Students the opportunity to experience the Examity environment, including connecting to an online proctor and uploading a response file; and to familiarize Students with the Institute's Examination Rules. The last day that Students can write the Practice Quiz is Monday, October 28, and the last day that Students may sign up to take a Practice Quiz is Sunday, October 27 (i.e., 24 hours prior to when the Student wishes to write the Practice Quiz). The answers to the Practice Quiz will be available in Moodle on Thursday October 31. THE IVSC IS CREATING A DATABASE OF VALUERS TRAINED IN IVS – DO YOU QUALIFY TO BE INCLUDED?

The International Valuation Standards Council (IVSC) frequently receives enquiries from users of valuation services seeking information on professionals who are trained and equipped to provide IVS-compliant valuations. To this

end, the IVSC is creating a global database that will be searchable country-by-country and will enable members of the public to access that data to make informed decisions when selecting a valuation professional. CBV Institute is working with the IVSC to ensure CBVs are included.
