Fall Course Exams and Practice Quiz – Examity Scheduling Deadline (Monday October 28th, 2019)

Students must create a profile and schedule their course exams with Examity by October 28th. Students must write their exams using Examity (no exceptions).

Further, Students are encouraged to register for and write a Practice Quiz in Examity. The purpose of the Practice Quiz is to give Students the opportunity to experience the Examity environment, including connecting to an online proctor and uploading a response file; and to familiarize Students with the Institute's Examination Rules. The last day that Students can write the Practice Quiz is Monday, October 28, and the last day that Students may sign up to take a Practice Quiz is Sunday, October 27 (i.e., 24 hours prior to when the Student wishes to write the Practice Quiz). The answers to the Practice Quiz will be available in Moodle on Thursday October 31. DID YOU KNOW...

IVS 2017 HAS BEEN UPDATED AND RE-ISSUED AS “IVS”

The latest edition of the International Valuation Standards (IVS) has now been published. Going forward, the year of publication is no longer included in the title of the standards, such that the standards are now simply called IVS (rather than IVS 2019). This latest edition of IVS includes several changes:

- a new chapter, 'IVS 220 Non-Financial Liabilities' as part of the intangible asset standards
- technical revisions consulted on throughout 2018 and 2019
- an updated IVS Glossary
- updated standards on 'limitations' (IVS 102), and 'valuation models' (IVS 105).
