You can now look at job opportunities, submit your Practice Inspection declaration, pay fees, browse and register for events and much more, all from your phone.


To download, please go to the <u>App Store</u> and <u>Google Play</u>. Once downloaded, use your covinstitute.com log in information to access the app.

#### What is the App and why should I download it?


